(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Six Thousand and No/100**

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Austin Township, on the Northern side of Hyde Circle, being shown as Lot No. 3 on Plat of property of Frank Smith, et al, made by J. L. Hunter on April 26, 1951, and, according to said Plat, is described as follows:

BEGINNING at a point in Hyde Circle, at corner of property of A. B. Clark and Mary A. Clark, and running thence with the line of said property, N. 13-25 W. 299.4 feet to an iron pin; thence N. 74-45 E. 72 feet to an iron pin; thence along the line of Lot No. 4, S. 13-25 E. 300 feet to point in Hyde Circle; thence S. 75-15 W. 72 feet to the beginning corner.

BEGINNING at an iron pin at the joint corner of Lots Nos. 2 and 3; thence along the line of Lot No. 3, N. 13-25 W. 299.4 feet to an iron pin; thence S. 75-25 W. 149.4 feet to an iron pin at the corner of Lot No. 1; thence along the line of Lot No. 1, S. 13-25 E. 298.1 feet to a point located on the Northern side of Hyde Circle; thence continuing along Hyde Circle, N. 75-15 E. 149.4 feet to the beginning corner.
