TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Clifton A. Stokes

(Hereinafter referred to as Mortgagor) SEND(S) GREETING.

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Highland Township, situated on the west side of the Jordan Road, near Jordan School, containing 46 acres, more or less, bounded by lands now or formerly belonging to Hilton Babb, J.A. Harman, and others, and being the same property conveyed to the mortgagors herein by E. Inman, Master by deed recorded in Deed Book 573, page 525, R.M.C. Office for Greenville County.
