WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of NINE THOUSAND

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor are any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and telivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs

Township and in the City of Greer, being shown and designated as Lot

No. 157 on a plat of property made for H.P. McManus by H.S. Brockman, Surveyor, dated January 21, 1959, and having the following

courses and distances, to-wit:

BEGINNING, on an iron pin at the corner of Hunt Street and Overbrook Drive, and runs thence with the margin of Overbrook Drive, S. 81-04 E. 70.1 feet to an iron pin, corner of Lots Nos. 157 and 199; thence with the common line of Lots Nos. 157 and 159, S. 12 W. 168.7 feet to an iron pin on line of Lot No. 158; thence N. 78-00 W. 70 feet to an iron pin on the eastern margin of Hunt Street; thence with the margin of that street, N. 12-00 E. 165 feet to the beginning corner.
