(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

situate on the northwest side of Converse Street (formerly Circle Street) shown as lot # 7 on a plat of Hillside Heights recorded in the RMC office for Greenville County in Plat Book F at Page 100, and described as follows:

BEGINNING at an iron pin on the northwestern side of Converse Street, at the joint front corner of lots # 7 and 8, and running thence along the line of lot 8, N. 43-37 W. 169 feet to iron pin; thence N. 12-12 E. 25 feet to iron pin, corner of lot # 6; thence with the line of lot # 6, S. 75-3 E. 184.6 feet to iron pin on the northwestern side of Converse Street; thence along said street, S. 29-49 W. 60 feet to a point; thence continuing with said street, S. 38-35 W. 60 feet to the beginning corner.
