Brannon , in consideration of the said debt and sums of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to the said mortgagor. B. in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Spartanburg, Beech Springs Township, near the eastern corporate limits of the town of Greer, and designated as lots Nos. 5-6-7 on Plat recorded in Plat Book 20, page 136, and having together the following courses and distances to wit:

BEGINNING at the joint corner of lots 4 and 5 on the western side of Rhett Street, and runs thence along the rear lines of lots 4-3-2-1 westerly two hundred (200) feet to point on line of Miss Edna James; thence with her line, S. 12-30 W. 150 feet to corner of Lot #8; thence easterly as a dividing line we between lots 7-8, two hundred (200) feet to point on said Rhett Street; thence with said Rhett Street N. 12-30 E. 150 feet to the beginning corner; and bounded north by lots 1-2-3-4; east by Rhett Street; south by lot #8 and west by Miss Edna James.
