To All Whom These Presents May Concern:

I, Tandy Wilson hereinafter called the Mortgagor, SEND GREETING:

All that piece, parcel or lot of land in Chick Springs Township Greenville County, State of South Carolina, near the (Old) City Limits of the City of Greer, being all of Lot No. 6 in Block "A" on plat of the D.D. Davenport Estate, by H.S. Brockman, Surveyor, October 17, 1940 and recorded in the R.M.C. Office, Greenville County, and having the following courses and distances, to wit:

BEGINNING on an iron pin on the south side of Snow Street, joint corner of this lot with Lot No. 5, and runs thence with the line of Lot No. 5, S 7-55 W. two hundred eighty-two (282) feet to iron pin on line of Lot No. 12; thence with the line of Lot No. 12, S. 83-15 E. fifty three and eight tenths (53.8) feet to iron pin, corner of Lot No. 11, thence N. 7-05 E. two hundred eighty-one (281) feet to iron pin on the south side of Snow Street; thence with Snow Street, south side, N. 82-05 W. fifty (50) feet to the beginning corner; together with all improvements thereon.
