Carolina, being known and designated as Lot No. 64 on plat of Woodfields
subdivision made by C. C. Jones, October 1947 recorded in plat book S
page 7 of the RMC Office for Greenville County, S. C., said lot having
a frontage of 70 feet on the northwest side of Ridgeway Drive, a depth
of 198.6 feet on the southwest side, a depth of 200.2 feet on the
northeast side and a rear width of 70 feet.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter
