WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by

reference, in the sum of **One Thousand Five hundred and no/100**

DOLLARS (\$ **1,500.00**), with interest thereon from date at the rate of **seven** per centum per annum, said principal and interest to be paid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate lying and being in the State of South Carolina, County of Greenville, being known as a portion of lot 64 on plat of Parker Land Company recorded in the R. M. C. Office for Greenville County in plat book F at page 276 and having the following metes and bounds, to-wit:

Beginning at a point at or near the center of South Parker Road, which iron pin is situate approximately 192 feet east of the intersection of New Buncombe Road and running thence along the line of Doris M. Hughes N 20 W, 201 feet to an iron pin; thence along the property of S. M. Rogers N 63-38 E, 100 feet, more or less, to the corner of property of Mary Deal; thence along the property of Deal S 21-19 E, 189.3 feet (see plat book Z at page 135); thence along the center of South Parker Road S 57-30 W, 106 feet to the point of beginning and being the same property conveyed to me in deed book 345 at page 221, less conveyance out in deed book 430 at page 33.
