Six (6) months from date or whenever the mortgaged premises shall be conveyed by the mortgagor herein, whichever date is earlier,

with interest from date at the rate of six (6%) per centum per annum until paid; interest to be computed and paid at maturity and if unpaid when due to bear interest at same rate as principal until paid, and I have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said Clarence M. Traynham

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Greenville Land Co., Inc., its successors and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as Lot No. 106 of a subdivision known as Orchard Acres, Section Two, as shown on a plat of a portion of said subdivision prepared by J. Mac Richardson, Surveyor, March, 1960, and recorded in the R. M. C. office for Greenville County in Plat Book QQ, at page 6, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern edge of Ridge Spring Street, joint front corner of Lots 105 and 106, and running thence along the southern edge of Ridge Spring Street, N. 85-36 E. 148.6 feet to a concrete monument; thence following the curvature of the intersection of Ridge Spring Street with Orchard Drive, the chord of which is S. 19-03 E. 51.2 feet to an iron pin on the western edge of Orchard Drive; thence along the western edge of Orchard Drive, following the curvature thereof, the chord of which is S. 34-43 W. 106.3 feet to a concrete monument; thence continuing along the western edge of Orchard Drive, S. 20-17 W. 79.8 feet to an iron pin at the corner of Lot No. 118; thence along the line of that lot, N. 85-45 W. 61.5 feet to an iron pin at the rear corner of Lot No. 105; thence along the line of that lot, N. 4-24 W. 194.9 feet to the beginning corner; being the same conveyed to me by Greenville Land Co., Inc. by deed dated February 17, 1961, to be recorded herewith.

And I do hereby bind myself, my Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the said mortgagee, its successors ~~Heirs~~ and Assigns, from and against me, my Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming, or to claim the same or any part thereof.
