All that piece parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate lying and being on the Northern side of Arlington Road, Chick Springs Township near Paris Station in Greenville County, State of South Carolina, being known and designated as Logt No. 27 as shown on a plat of the W.A.
