NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Barton Road about two and one-half miles from Gowensville, Highland Township, Containing 4.9 acres, more or less, and having the following courses and distances, to-wit:

BEGINNING on a nail (old) in Spartanburg Road, iron pin on line at S. 36-05 W. 20 feet, also iron pin reference at S. 19-20 W. 15 feet; thence with said road, N. 75-30 W. 289 feet, N. 62 W. 100 feet, N. 47-45 W. 412.8 feet, to intersection of west side of old Greenville-Rutherford Road; thence with old road, S. 24 W. 180 feet to point in Barton Road; thence with Barton Road, S. 78-15 E. 30.4 feet, S. 36-35 E. 400 feet and S. 26-10 E. 384.4 feet to iron pin, line formerly of Oma Morrow; thence leaving road, and with Morrow line, N. 36-05 E. 542.7 feet to the beginning, old stone reference, S. 36-05 W. 63 feet, from pin in Barton Road.
