"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying on the North-western side of Longview Terrace in the City of Greenville, shown as Lot No. 18 on a plat of part of the Estate of J. T. Blassingame, recorded in Plat Book J at page 117 and according to said plat described as follows:
