4% With respect to the within described promises, Mortgagors will

- a. Insure and keep maured the same and all improvements thereon and fixtures therein with fire and extended coverage insurance written by a casualty company acceptable to Mortgageo, for not less than the amount due herounder, said insurance to be payable to and to protect Mortgageo and/or Mortgageo's assigns; and
- b. assign such policy of fire and extended coverage insurance to Mortgagee; and
- e. pay all taxes, levies, and assessments upon said premises; and
- d. will, at Mortgageo's option, exhibit to Mortgageo receipts evidencing payment of said fire and extended coverage insurance premiums and said taxes.

Should Mortgagors fail to perform Mortgagors' covenants hereinabove provided, Mortgagoe may place insurance in its own name and pay the promiums therefor and may pay said taxes, levies and/or assessments.
