All of that lot of land in the County of Greenville, State of South Carolina, at Paris S. C. being all of lots 14 and 15 and a portion of lots 11, 12, 13 and 16 on plat of Realty Corp., a subdivision of Traxler at Paris, S. C. recorded in plat book F at page 211 and having the following metes and bounds, to-wit:

Beginning at an iron pin at the northern intersection of Cuttino Rd. and Camp Rd. and running thence along the northern side of Camp Road N 55 E, 80 feet to an iron pin; thence N 38-15 W, 180 feet to an iron pin at or near the rear corner of lots nos. 11, 12 and 18; thence cutting through lots 12, 13 and 16, S 14-20 W, 150 feet to an iron pin on Cuttino Road; thence with Cuttino Road S 67 E, 83.5 feet to the point of beginning.
