Extension, being a portion of Lots Nos. 29 and 30 according to plat of  
F. B. Massingale made by J. Coke Smith May 16, 1947, and having the  
following metes and bounds:

BEGINNING at a point on the south side of Arch Street Extension four  
feet from the joint front corner of Lots Nos. 29 and 30, at corner of lot  
formerly owned by Emmett Lee, and running thence in a southeasterly  
direction with Emmett Lee line (which line is parallel with the joint  
line of Lots Nos. 28 and 29) 111 feet to stake at corner of lot now or  
formerly owned by Ollie H. Ray; thence with Ray line N. 60-25 E. 91 feet  
to stake at corner of strip conveyed to Ollie H. Ray; thence with Ray  
line in a southwesterly direction 129 feet, more or less, to a stake on
