NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagor, and also in consideration of the further sum of Three dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Pickens, about one mile North of the Town of Pickens, and being more fully described as follows: BEGILLIC on an iron win on bank of road, which point is also corner of Rubert Lark; thence be 6-00 W 210 feet to an iron pin; thence S 86-38 E 105 feet to iron pin; thence S 6-00 E 210 feet to an iron pin; thence S 86-38 W 105 feet to the point of BEGINLING, and containing 0.5 acre, more or less, and being bounded on the North and fast by lands of Roser; on the So th by road leading to U. S. Highway 178; on the West by Inde of Rubert Lark, according to plat of Thomas C.
