NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of those presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of Shannon Lake Circle, in Butler Township, being shown as all of Lot 10, and a portion of Lot 11, as shown on plat of Shannon Forest, recorded in Plat Book KK at page 141, and being more particularly described as follows:

BEGINNING at an iron pin on the Western side of Shannon Lake Circle at the joint front corner of Lots 9 and 10 and running thence with the line of Lot 9, N. 63-36 W. 249.4 feet to a pin; thence S. 32-33 W. 125.7 feet to a pin; thence S. 51-32 105.2 feet to a pin; thence S. 71-26 E. 161.5 feet to a pin on Shannon Lake Circle; thence with the Northwest side of Shannon Lake Circle, N. 26-24 E. 125 feet to the Beginning.
