Whereas, I, the said Fred C. King

at the rate of 6 per centum per annum, to be computed and paid annually
until paid in full; all interest not paid when due to bear

King; thence S. 27 W. 209 feet to an iron pin; thence N. 63 W. 209 feet to an iron pin; thence N. 27 E. 209 feet to the point of beginning and bounded by lands of Ruth S. King and the Dunklin Bridge Road.
