(hereinafter referred to as Mortgagor) SEND(S) GREETING;

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Fourteen Thousand Seven Hundred and No/100-----

DOLLARS (\$ 14,700.00 ), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid in monthly instalments of Ninety-Five and No/100----- Dollars (\$ 95.00 ) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

lying on the northern side of Hartsville Street, being known and designated as lot # 196, on a plat of Orchard Acres, Section 3, recorded in Plat Book QQ at Page 143, in the RMC office for Greenville County, and being further described according to said plat as follows:

BEGINNING at an iron pin on the northern side of Hartsville Street at the joint front corner of lots # 196 and 197; running thence along the joint lines of lots # 196 and 197, N. 3-21 W. 160 feet; thence S. 86-39 W. 90 feet to an iron pin at corner of lot # 195; thence along the joint lines of lots # 195 and 196, S. 3-21 E. 160 feet to an iron pin on the northern side of Hartsville Street; thence along Hartsville Street, N. 86-39 E. 90 feet to the beginning.

Being the same property conveyed to the mortgagors by deed of J. W. Pitts, of even date, to be recorded herewith.

Together with all and singular the-rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
