interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that piece, parcel or lot of land in Bates Township, Greenville County, State of South Carolina, in Traveler's Rest, on North side of West Road, being known and designated as Lot Number one (#1) in section "A" on a plat of "Roosevelt Rights" made by N.O. McDowell, Jr., Sur., recorded in Plat Book "3" at page #203 in R.M.C. Office, and having the following metes and bounds, to-wit:

BEGINNING AT AN IRON PIN, on northern side of West Road at its intersection with Booker Street, and running thence N. 21-15 W. 300 Feet along Booker Street to point, iron pin, on southern side of Roosevelt Avenue; thence N. 68-45 E. 75 feet along southern side of Roosevelt Avenue to point, iron pin, joint corner with Lot # 8; thence S. 21-15 E. 300 feet along the line of Lot #8 and #2 to point, iron pin on northern side West Road; thence S. 68-45 W. 75 feet along northern side of West Road to the point of beginning.

This is the same property conveyed to me by W.H. Williams by deed dated April 21, 1954, recorded in Vol. #449 at page 113 in said R.M.C. Office.
