"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Austin Township, at Five Forks, being Lot 5 on plat by W. A. Christopher, Surveyor, September 1921, recorded in the R. M. C. Office for said County in Plat Book Q at page 71. Said tract contains 9.79 acres, more or less, and is located about 11 miles easterly from the City of Greenville. It begins in center of the Greenville-Woodruff Road at joint corners of tracts 5 and 6, thence along line of property now or formerly of G. L. Smith South 29 East 18.51 to stake at corner of tract 4, thence North 68-20 East 9.88 to corner in center of aid road, thence North 49-05 West 6.11 to bend in road, thence North 58 West 16.16 to the beginning.

The foregoing lot was conveyed to mortgagor by deed of Thomas B. Waters, April20, 1955, and recorded in the R. M. C. Office aforesaid in Deed Book 523 at page 370.
