cured hereby), said note to be repaid with interest at the rate specified therein in installments of

Fifty-Nine and 47/100 - - - - - - - - (s. 59.47) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently

extended, will be due and payable. 20 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or fallure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS. AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

M. C. office for Greenville County in Plat Book S, at pages 70 and 71, and being also known and designated as Lot 19 A of the property of Amie Mimms as shown on plat thereof prepared by C. C. Jones, Engineer, December 13, 1960, and recorded in the R. M. C. office for Greenville County in Plat Book _____, at page _____, and having, according to the last mentioned plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northern side of Glenn Road, the joint front corner of this lot and Lot No. 20 of the Glenn Farms Subdivision, and running thence along the joint line of said lots, N. 3-00 E. 202 feet to an iron pin; thence S. 87-30 E. 50.45 feet to an iron pin at the rear corner of Lot No. 19 B; thence along the line of Lot No. 19 B, S. 3-31 W. 214.3 feet to an iron pin on the northern side of Glenn Road; thence along the northern side of Glenn Road, N. 73-00 W. 50 feet to the beginning corner; being the same conveyed to us by J. H. Mauldin by deed of even date, to be recorded herewith."
