WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgage at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as Lot No. 81, as shown on Plat No. 2 of Sunset Hills, recorded in Plat Book P at Page 19, and being more particularly described according to a survey prepared by C. C. Jones, as follows:

"BEGINNING at an iron pin in the southwestern side of Sunset Drive, which pin is 300 feet from the southwestern intersection of Sunset Drive and Waccamaw Avenue, and is the joint front corner of Lots Nos. 80 and 81, and running thence with Sunset Drive, N. 41-10 W. 75 feet to iron pin, corner of Lot No. 82; thence with line of said lot, S. 48-50 W. 175 feet to an iron pin in the northeastern side of a five foot strip reserved for utilities; thence with said strip, S. 41-10 E. 75 feet to an iron pin, rear corner of Lot No. 80; thence with line of said lot, N. 48-50 E. 175 feet to the point of beginning."
