C. office for Greenville County in Plat Book MM, at page 135, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southern side of East Lee Road, joint front corner of Lots 13 and 14, and running thence along the southern side of East Lee Road, N. 67-05 E. 70 feet to an iron pin; thence following the curvature of East Lee Road as it intersects with Live Oak Way, the chord of which is S. 67-55 E. 28.3 feet to an iron pin on the western side of Live Oak Way; thence along the western side of Live Oak Way, S. 22-55 E. 155 feet to an iron pin at a rear corner of Lot No. 22; thence along the rear line of that lot, S. 67-05 W. 90 feet to an iron pin at a rear corner of Lot No. 13; thence along the line of that lot, N. 22-55 W. 175 feet to the beginning corner; being the same conveyed to me by Leslie & Shaw, Inc. by deed dated April 13, 1961, to be recorded herewith."
