"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

All that giece, parcel or lot of land situate, lying and being in the City and County of Greenville, State of South Carolina, on the northern side of Cammer Avenue, being shown ав Lot No., 20 on mat of the property of G. F. Cammer made by R. E. Dalton in February 1923 and having, according to said plat, the following metes and bounds, to-wit:
