(hereinafter referred to as Mortgagor) SEND(S) GREETING;

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twenty-five Thousand and No/100 ----- DOLLARS (\$ 25,000.00 ) with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid in monthly installments of Two Hundred Seventy-eight and No/100 Dollars (\$ 278.00 ) each on the first day of each month hereafter until the principal and interest are fully paid, each payment to be applied first to payment of interest and then to payment of principal, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose including advances made by the Mortgagee on other or no security

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern corner of Pearce Avenue (formerly Eisenhower Avenue) and Grand Avenue in the City of Greenville, and described as follows:

BEGINNING at a stake at the northwestern corner of Pearce Avenue and Grand Avenue and running thence with the western side of Grand Avenue N. 20-05 W. 153.2 feet to an iron pin at the corner of property of J. P. Medlock; thence with the line of said property S. 69-32 W. 120 feet to an iron pin in the rear line of Lot 11 of Hutton Court; thence S. 13-38 W. 30.9 feet to an iron pin at the joint rear corner of Lots 11 and 13 of Hutton Court; thence with the line of said Lot 13 S. 16-21 E: 150 feet to an iron pin on Pearce Avenue; thence with the northern side of Pearce Avenue N. 65-42 E. 75 feet and N. 56-55 E. 74.1 feet to the beginning corner.

Being the same property conveyed to the mortgagor by deed recorded in Deed Book 670, Page 356.
