"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, IN BUTLER TOWNSHIP, NEAR THE CITY OF GREENVILLE, AND KNOWN AND DESIGNATED AS LOT NO. 37, ON THE EASTERN SIDE OF CARTER DRIVE, PART OF A SUBDIVISION KNOWN AS LAUPEL HEIGHTS, AND REING MORE PARTICULARLY DESCRIBED ACCORDING TO PLAT RECORDED IN THE RMC OFFICE FOR GREENVILLE GOUNTY IN PLAT BOOK KK, AT PAGE 23, AND HAWING THE FOLLOWING METES AND BOUNDS, TO-WIT:

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgages, its heirs, successors and assigns, forever.

The Mortgegor covenants that in is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and visit lawfully authorized to sall, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever detend all and singular the said premises unto the Mortgagor form and against the Mortgagor and all persons whomsoever fawfully claiming the same or any part thereof.
