"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Austin Township, composed of Lots 10 and 11 on plat of property of Rosa G. Moore, by C. O. Riddle, Surveyor, April, 1955, and recorded in the R. M C. Office for said County, and having the following metes and bounds: Bounded on the North by South Sunset Drive for 191, B feet, on the East by Lot 9 of said survey for 137. 9 feet, more or less, on the Southby other lands of mortgagors, acquired by Elizabeth B. Hughes, for 207.8 feet and on the West by lands of Rosa G. Moore for 139.1 feet.

This is a portion of the land conveyed to the mortgagors by deed of Rosa G. Moore, December 21, 1959, and recorded in the R. M G. Office aforesaid in Deed Book 641 at page 279.
