WHEREAS I/we the aforesaid mortgagor (s) in and by my/our certain promissory note in writing, of even date with these presents am/are well and truly indebted to EVEST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Fourteen Thousand. Pive Hundred & No./100 -(\$ 14, 500, 00) Dollars (or for juture advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of...

One Hundred Three and 80/100 -- 's' 103.90 Dollars upon the first day of each and every raienday month thereafter in advance until the full principal sum, with interest, has been paid, such mannily payments to be applied first to the payment of interest, computed monthly on the impaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and it not subsequently

extended will be due and payable. 220 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past disc and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said. Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an afterney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW/KNOW ALL MEN. That I/we, the said mortgagor(s) (in consideration of the said debt and sum of money aforesaid and for the better accuring the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the jurther sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released and by these presents do grant, bargain sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, near the City of Greenville, being a portion of Lots Nos. 5 and 6 according to a map of a subdivision known as Morgan Hill Addition, prepared May 5, 1902, recorded in the R. M. C. office for Greenville County in Plat Book A, at page 68, and having according to a more recent plat of property of George D. Ledbetter prepared September 13, 1952 by C. C. Jones, Engineer and recorded in the R. M. C. office for Greenville County in Plat Book CC, at page 157, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the eastern side of Woodside Avenue at the joint corner of property now or formerly of Mrs. Clyde Thompson; running thence along the line of her property, S. 84-36 E. 173.4 feet to an iron pin; thence S. 9-35 W. 87.8 feet to an iron pin on the northern side of City View Street; running thence along the northern side of said City View Street, S: 82-45 W. 188.4 feet to an iron pin in the intersection of said Woodside Avenue and said City View Street; thence along the eastern side of said Woodside Avenue, N. 12-55 E. 130 feet to the point of beginning; being a portion of the property conveyed to me by C. M. Ledbetter by his deed dated March 11, 1946 and recorded in the R. M. C. office for Greenville County in Deed Vol. 308, page 45.
