cured hereby), said note to be repaid with interest at the rate specified therein in installments of

"BEGINNING at an iron pin on the northern side of a five foot sidewalk on the northern side of Paris Mountain Avenue at the joint front corner of Lots Nos. 44 and 45, and running thence along the joint line of said lots, N. 5-50 W. 102 feet to an iron pin in the line of Lot No. 43; thence along the line of Lot No. 43, N. 87-45 E. 65 feet to an iron pin, the joint rear corner of Lots Nos. 45 and 46; thence along the joint line of said lots, S. 5-50 E. 98 feet to an iron pin on the northern side of said five foot sidewalk, joint front corner of Lots 45 and 46; thence with the northern side of said five foot sidewalk on the northern side of said Paris Mountain Avenue, S. 84-28 W. 65 feet to the point of beginning; being the same conveyed to us by Allen E. Vaughn by deed of even date, to be recorded herewith."
