(2) The mortgagor/tenant of the mortgagor has entered into or is about to enter into a lease agreement and conditional sale contract/chattel mortgage agreement with AMF Pinspotters Inc. for the installation and use of ten (10) AMF Automatic Pinspotters machines, and certain other machines and/or equipment specified as follows:

5 pr. AMF Single T bowling lanes; 5 pr. Single T Sub-foundations; 10 interdays-installed; 6" ft. filler between lanes at columns; 5 deluxe score tables styrex; 1 30 opening rack; 1 10 team lane designator; 10 10 compartment lockers-2 balls each; 1 AMF ball cleaning machine; 3 deluxe ball storage racks with casters; 7 Imperial sand urns; 1 10 frame league standing frames; 1 10 frame combination sanction & schedule frames; 5 curved fiberglass bowlers settees; 50 #100 spectator seats; 1 19" floor polishing machine; 10 5 ply maple score chairs with self levelers; 1 tool kit; 10 pit signal system; 1 spare parts inventory

including replacements thereof and appurtenances thereto, which machines and equipment are to be installed and used at the above mentioned premises.

Now, THEREFORE, in consideration of the agreement to lease said AMF Automatic Pinspotters machines and the agreement to sell the aforesaid other machines and/or equipment under a said time payment contract to AMF Pinspotters Inc., together with other good and valuable consideration, receipt of which is hereby acknowledged, said mortgagee/trustee consents to the installation and use of said machines and/or equipment and hereby agrees that said mortgagee/trustee shall not have or acquire any right, title or interest in or to said machines and equipment by reason of attachment thereof to the premises, or otherwise; that the representatives, agents and employees of AMF Pinspotters Inc., its successors and assigns, may enter upon said premises and/or bowling alleys and remove said machines and/or equipment in the event of breach, termination, suspension, or cancellation of any agreement under which said machines and/or equipment are installed and/or used; and hereby expressly waives in favor of AMF Pinspotters Inc., its successors and assigns, any claim, interest, right or lien now in existence or hereafter acquired in, on, onto the said machines and/or equipment, replacements thereof and additions thereto.

This mortgage/trust modification, waiver and consent shall be binding upon the heirs, executors, administrators, successors and assigns of the undersigned.
