(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eight Hundred Fifty and No/100

DOLLARS (\$ 850.00) with interest thereon from date at the rate of seven (7%) per centum per annum, said principal and interest to be repaid in monthly instalments of Twenty-two and No/100 Dollar (\$ 22.00) each on the first day of each month hereafter until the principal and interest are fully paid, each payment to be applied first to payment of interest and then to payment of principal, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwestern side of Fifth Avenue in the Village of F. W. Poe Manufacturing Company being shown and designated as Lot 160 on plat of F. W. Poe Manufacturing Company recorded in Plat Book Y, Pages 26-29, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Fifth Avenue at joint front corner of Lots 159 and 160, and running thence with the line of Lot 159 S. 49-0 W. 99.2 feet to pin; thence with the rear line of Lot 140 N. 41-15 W. 75 feet to pin at rear corner of Lot 161; thence with the line of Lot 161 N. 49-0 E. 99.3 feet to pin on Fifth Avenue; thence with the southwestern side of said avenue S. 41-10 E. 75 feet to point of beginning.

Being the same premises conveyed to the mortgagor by deed recorded in Deed Book 420, Page 213.
