SEND GREETINGS

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Nine Thousand and No/100 - (\$ 9,000.00) bollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the max.mum amount stated herein and shall be evidenced by a subsequent promisery note or notes secured hereby), said note to be repaid with interest at the rate specified therein in install that of

Sixty-Eight and 24/100 - (\$ 68.24 Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such manthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently

extended, will be due and payable. 18 byears after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the liy-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and forcelose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

"BEGINNING at an iron pin on the northern side of Sylvania Drive, the joint front corner of Lots #12 and #11, and running thence along the line of these lots, N. 56-48 E 144.2 feet to an iron pin in the line of Lot #13; running thence S. 33-02 E. 89.9 feet to an iron pin at the joint rear corner of Lots #12 and #14; running thence S. 66,48 W. 148.9 feet to an iron pin on the northern side of Sylvania Drive; running thence along the northern side of Sylvania Drive, the following courses and distances, to-wit: W. 32-42 W. 24.6 feet to an iron pin; thence N. 28-24 W. 65 feet to an iron pin, point of beginning; being the same conveyed to me by Horace P. Baumgardner as Trustee by deed dated May 22, 1961, to be recorded herewith."
