SEND GREETINGS

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Eleven Thousand, Two Hundred Fifty & no/100 (\$11,250.00) Dollars (or for luture advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

Ninety-Four and 95/100 --- (\$ 94.95) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently

extended, will be due and payable 15 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under-said note, shall, at the option of the holder, become immediately due and payable, and the holder have thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney system as part thereof, if the same be placed in the hands of an attorney for dylection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN OF Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the fighther sum INGS AND LOAN ASSOCIATION OF GREENVILLE, at hand well and truly paid by the said FIRST FEDERAL SAV-whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, at the northeast corner of the intersection of Whitehall and Randall Streets, being the front portion of Lot No. 11, Section A, of the Stone Land Company property according to plat of the same recorded in the R. M. C. office for Greenville County in Plat Book A, at page 336, and having the following metes and bounds, to wit:

"BEGINNING at the northeast corner of the intersection of Whitehall Street and Randall Street, and running thence along the north side of Randall Street, S. 85-39 E. 70 feet to the porner of Lot No. 12; thence with the line of Lot No. 12, N. 1-41 E. 150 feet, more or less to the corner of a lot now or formerly belonging to H. B. Springs; thence with the line of that lot, N. 85-39 W. 70 feet to a pin on the east side of Whitehall Street; thence along the east side of Whitehall Street, S. 1-41 W. 150 feet, more or less, to the beginning corner; being the same conveyed to me by T. C. Stone by his deed dated December 10, 1940 and recorded in the R. M. C. office for Greenville County in Deed Vol. 227, at page 126."
