C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

per centum per annum, said principal and interest to be repaid in monthly instalments of

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of U. S. Highway Alternate Route 13, near Saluda River, in Greenville Township, near the City of Greenville, and being shown as Lots 11 and 12 on plat of property of L. A. Whitmire Estate, recorded in Plat Book Y at Page 87, and described as follows:

"Lot 11: BEGINNING at a stake on the northern side of U. S. Highway Alternate Route 13, 650 feet west from a county road at the corner of Lot 10, and running thence with the northern side of the right-of-way of said highway, S. 85-18 W. 100 feet to stake at corner of Lot 12; thence with line of said lot N. 3-11 W. 200 feet to stake on a 25 foot alley; thence with the southern side of said alley N. 85-18 E. 100 feet to stake at corner of Lot 10; thence with line of said lot S. 3-11 E. 200 feet to the beginning corner.

"Lot 12: BEGINNING at an iron pin on the northern side of U. S. Highway Alternate Route 13, at joint front corner of Lots 11 and 12, and running thence along line of Lot 11, N. 3-11 W. 200 feet to an iron pin on south side of a 25 foot alley; thence along the south side of said alley S. 84-33 W. 100 feet to iron pin; thence along line of Lot 13, S. 3-11 E. 200 feet to iron pin on the north side of U. S. Highway Alternate Route 13; thence along the northern side of said Highway N. 84-33 E. 100 feet to the beginning corner."

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
