TO ALL WHOM THESE PRESENTS MAY CONCERN:

ROSE B. KUBLER AND DONALD G. KUBLER (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eighteen Thousand and No/100 DOLLARS (\$18,000.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid in monthly instalments of One Hundred Sixteen and No/100 Dollars (\$116.00) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying on the western side of Linden Drive, near the City of Greenville, shown as Lot 14 on a plat of Pinehurst, Section 2, recorded in Plat Book MM, Page 153, and according to said plat described as follows:

BEGINNING at an iron pin on the western side of Linden Drive at the front corner of Lot 13 which pin is 218 feet north of a concrete monument on the western side of said drive at the joint corner of Lots 11 and 12 and running thence with the western side of Linden Drive N. 25-39 W, 35 feet to an iron pin; thence with the curve of the western side of said drive N. 18-47 W, 45 feet to an iron pin at the front corner of Lot 15; thence with the line of said lot S. 86-05 W. 204.8 feet to an iron pin; thence S. 29-57 E. 157.5 feet to an iron pin at the rear corner of Lot 13; thence with the line of said lot N. 64-18 E, 171.3 feet to the beginning.
