TO ALL WHOM THESE PRESENTS MAY CONCERN: I, **Hassie B. Eberhardt**

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate, lying and being on the west side of Jaben Drive, and being known and designated as Lot No. 6 of the property of B. P. Crenshaw, according to plat made by Dalton and Neves, Engineers, September 1956, said plat being recorded in the R.M.C. Office for Greenville County in Plat Book LL at Page 142, and according to said plat being more particularly described as follows:

"BEGINNING at an iron pin at the joint corner of Lots 4 and 6, and running along the line of Lots 3 and 4, N. 59-41 W. 158.8 feet to an iron pin at the joint rear corner of Lots 2, 3 and 9; thence along the line of Lot No. 9, S. 16-30 W. 36.2 feet to an iron pin at the joint rear corner of Lots 8 and 9; thence along the line of Lots 7 and 8, S. 32-25 E. 144 feet to an iron pin on Jaben Drive; thence along Jaben Drive, N. 49-55 E. 54.6 feet to an iron pin; thence continuing along Jaben Drive, N. 34-55 E. 50 feet to an iron pin at the beginning corner."

Being the same property conveyed to the mortgagor by deed recorded in Book of Deeds 673 at Page 104.
