well and truly indebted to

Dollars, in and by our certain promissory note in writing of even date herewith, due and payable  
on the first day of June 1961

to be paid \$79.90, July 1, 1961, and \$79.90 on the first day of each  
succeeding month thereafter until paid in full, with payments to be  
applied first to the semi-annual interest as it comes due, and then  
to the principal.

from June 1, 1961, at the rate of six per centum per annum  
until paid, interest to be computed and paid semi-annually, and if unpaid when due to  
bear interest at same rate as principal until paid, and we have further promised and agreed to pay ten per  
cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal  
proceedings of any kind, reference being thereto had will more fully appear.

NOW, KNOW ALL MEN, That we, the said Glenn Pope Arthur and Martha  
Lominack Arthur, in consideration of the said debt and sum of money  
aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and  
also in consideration of the further sum of Three Dollars, to us in hand well and truly paid at and before  
the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted,  
bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Citizens Lumber Company, a corporation,

all that tract or lot of land in  
Greenville Township, Greenville County, State of South Carolina,  
known as Lot No. 4 of Rockvale as shown by a plat thereof made by J.  
Mac Richardson, dated October 19, 1958, and having, according to said  
plat, the following metes and bounds:

BEGINNING at an iron pin on the northern side of Rockvale  
Drive at the corner of Lot 3 and running thence, S. 84-03 W., 9.5 feet  
to a concrete monument; thence continuing with the northern side of  
Rockvale Drive, S. 81-54 W., 64.5 feet to a pin at the corner of Lot 5;  
thence with the line of that lot, N. 9-20 W., 162.2 feet to a pin on the  
subdivision property line; thence with the line of Thomas, N. 76-35 E.,  
20 feet to a pin; thence still with the line of Thomas, N. 83-30 E.,  
58.1 feet to a pin at the corner of Lot 3; thence S. 7-44 E., 181.7  
feet to the beginning corner.
