(hereinafter referred to as Mortgagor) SEND(S) GREETING

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Oriole Street, near the City of Greenville, being shown as lot # 31, on a plat of Wade Hampton Gardens, recorded in the RMC office for Greenville County in Plat Book MM at Page 199, and being more particularly described as follows:

BEGINNING at an iron pin on the eastern side of Oriole Street, front corner of lot # 30, and running thence with the line of said lot, S. 71-03 E: 175 feet to iron pin, rear line of lot # 41; thence with the line of lots # 41 and 40, N. 18-57 E. 110 feet to iron pin at the rear corner of lot # 32; thence with the line of lot # 32, N. 71-03 W. 175 feet to iron pin on the eastern side of Oriole Street; thence with the eastern side of Oriole Street, S. 18-57 W. 110 feet to the point of beginning.
