LANDERS (hereinafter referred to as Mortgagor) SEND(S) GREETING.

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Southern side of Ridge Spring Street near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 105 as shown on a plat prepared by J. Mac Richardson, R. L. S., dated March, 1960, entitled "Final Plat - Part of Section Two, Orchard Acres," recorded in the R. M. C. Office for Greenville County in Plat Book QQ at page 6, and having according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Ridge Spring Street at the joint front corner of Lots Nos. 104 and 105, and running thence with the line of Lot No. 104 S. 4-24 E. 181.2 feet to an iron pin in the line of Lot No. 118; thence with the line of Lot No. 118 S. 85-45 E. 91 feet to an iron pin at the joint rear corner of Lots Nos. 105 and 106; thence with the line of Lot No. 106 N. 4-24 W. 194.9 feet to an iron pin on the Southern side of Ridge Spring Street; thence with the Southern side of Ridge Spring Street S. 85-36 W. 90 feet to the point of beginning.
