TO ALL WHOM THESE PRESENTS MAY CONCERN:

BEN FOWLER, JR. and BEULAH S. FOWLER of Greenville County, S. C., hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto AIKEN LOAN & SECURITY COMPANY a corporation organized and existing under the laws of the State of South Carolina hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Eleven Thousand and No/100 Dollars (\$ 11,000.00), with interest from date at the rate of five & one-half per centum (5-1/2%) per annum until paid, said principal and interest being payable at the office of Aiken Loan and Security Company in Florence, South Carolina or at such other place as the holder of the note may designate in writing, in monthly installments of Sixty Two and 48/100 Dollars (\$ 62.48), commencing on the first day of August, 1961, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of July, 19 91.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that piece, parcel or lot of land situate in Garntt Township, Greenville County, State of S. C., being known and designated as Lot No. 2, Section 1, Rockvale subdivision, and being shown on a plat thereof prepared by J. Mac Richardson, Surveyor, and recorded in the RMC Office for Greenville County, in Plat Book QQ, Page 108, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin at corner of Lot No. 1 and the north side of Rockvale Drive, and running thence with north side of Rockvale Drive, S. 84-03 W., 75 feet to an iron pin; thence N. 7-41 W., 160.7 feet to an iron pin; thence N. 83-30 E., 40 feet to an iron pin; thence S. 69-0 E., 39.3 feet to an iron pin; thence S. 7-38 E., 142.9 feet to the point of BEGINNING.
