Nelson property made by Pickell & Pickell, Engineers, April 30, 1948, recorded in Plat Book U, at page 49), and having, according to said plat and a survey made by R. W. Dalton, September 11, 1948, the following mates and bounds, to-wit:

"BEGINNING at a stake on the eastern side of Alice Street, said stake being 135.6 feel south from the southeast corner of the intersection of Alice Street and McDowell Street, and running thence N. 85-32 E. 165.2 feet to an iron pin; thence S. 0-38 W. 60 feet to an iron pin; thence S. 72-37 W. 176.3 feet to an iron pin on the eastern side of Alice Street; thence along the eastern side of Alice Street, N. 2-36 E. 100 feet to the beginning corner; being the same conveyed to the mortgagor, Ode Cox, and his late wife, Grace Cox, by George W. Dawkins, et al. by deed dated October 20, 1950 and recorded in the R. M. C. office for Greenville County in Deed Vol. 421, page 506. As will appear by reference to Apt. 756, File 12, in the office of the Probate Court for Greenville County, the said Grace Cox died intestate September 6, 1960, leaving the mortgagors herein as her sole surviving heirs at law.
