"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, at Paris Station, being known and designated as Lot Nos. 32 and 33 of a subdivision known as Piedmont Estates, as shown on plat thereof prepared by Dalton & Neves, Engineers, December 1944, and recorded in the R.M.C. Office for Greenville County in Plat Book M, at Page 123 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Eisenhower Street, now known as Lofty Ridge Road, the joint front corner of Lots Nos. 33 and 34, and running thence along the southwestern side of Eisenhower Street, S. 66-56 E, 60 feet to an iron pin, the joint front corner Lots Nos. 32 and 33; thence continuing along the southwestern side of Eisenhower Street, S. 75-36 E. 75 feet to an iron pin; thence continuing along said Street, S. 88-30 E. 92.8 feet to an iron pin on the right-of-way of the P & N Railway; thence along said right-of-way, S. 46-27 W. 242 feet to an iron pin; thence N. 66-0 W. 127 feet to an iron pin at the rear corner of Lot No. 34; thence along the line of that lot, N. 24-0 E. 175 feet to the beginning corner; being the same property conveyed to me by deeds recorded in the R.M.C. Office for Greenville County in Deed Volume 539, Page 399 and Deed Volume 597, Page 133.
