THIS MORTGAGE, made, this 27th day of June, 1961, between

CARLOS F. LINDSEY and FRANCES M. LINDSEY

of the County of Greenville, State of South Carolina, hereinafter called Mortgagor, and THE PRUDENTIAL INSURANCE COMPANY OF AMERICA, a New Jersey corporation, having its principal office in Newark, New Jersey, hereinafter called Mortgagee.

ALL that lot of land with the buildings and improvements thereon, situate on the West side of Briarwood Boulevard, near the City of Greenville, in Greenville County, State of South Carolina, being shown as Lot 37 of Wildair Estates as shown on plat thereof made by Dalton & Neves, Engineers, April 1953, recorded in the RMC Office for Greenville County, S. C. in Plat Book "EE", page 19, said lot fronting 100 feet along the West side of Briarwood Boulevard, running back to a depth of 187 feet on the North side, to a depth of 182.2 feet on the South side, and being 100.12 feet across the rear.
