The Mortgagor further covenants and agrees as follows:

- That this mortgage shall secure the Mortgages for such further sums as may be advanced hereafter, at the option of the Mortgages, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes dursuant to the covenants herein. This mortgage shall also secure the Mortgages for any further loans, advances, readvances or credits that may be made hereafter to the Mortgager so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof.
