sum of \$ SIXTY-FIVE HUNDRED and no/100--- (\$ 6,500.00) Dollars,

with interest at the rate of six (6 %) per centum per annum, to be repaid in installments of

Fifty-four and 86/100--- (\$ 54.86) Dollars upon the first

day of each and every calendar month hereafter until the full principal sum, with interest, has been paid.
