And I do hereby agree to pay all taxes and other public assessments against this property on or before the first day of January of each calendar year, and to exhibit the tax receipts at the offices of the WOOD-RUFF FEDERAL SAVINGS AND LOAN ASSOCIATION, immediately upon magnicus, until all amounts due under this mortgage have been paid in full, and should .
