WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of One Hundred Ten Thousand and no/100----

DOLLARS (\$ 110,000.00---), with interest thereon from date at the rate of Five & one-half (per centum per annum, said principal and interest to be repaid in monthly instalments of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted; bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, sifuate, lying and being in the State of South Carolina, County of Greenville, situate at the Northwestern corner of the intersection of South Main Street and West McBee-Avenue in the City of Greenville, and being more particularly described as follows:

BEGINNING at an iron pin at the Northwestern corner of the intersection of South Main Street and West McBee Avenue, and running thence N. 18 E. 78:5 feet, more or less, to the corner of property formerly owned by J. H. Morgan; thence along the line of Morgan property, in a Westerly direction, 138.5 feet, more or less, to a 10 foot alley; thence with the Eastern side of said alley, S. 18-15 W. 78.5 Peet, more or less, to the intersection of said 10 foot alley and West McBeo Avenue; thence with the Northern side of Mest McBee Avenue, 140.5 feet, more or less to the Beginning.
