Whereas, I, the said Archie M. Thackson

hereinafter called the mortgagor(s)

in and by my certain promissory note in writing, of even date with these presents, am well and truly indebted to Farmers Bank of Simpsonville, South Carolina

one year from date,

with interest thereon from, date

at the rate of six (6%) percentum per annum, to be computed and paid

quarterly

interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if, before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor(s) promise to pay all costs and expenses (including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, That I, the said mortgagor(s), in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said mortgagee(s) according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me, the said mortgagor(s), in hand well and truly paid by the said mortgagee(s) at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said FARMERS BANK OF SIMPSONVILLE, SOUTH CAROLINA, ITS SUCCESSORS AND ASSIGNS:

All that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near Jonesville, and being a portion of the lands acquired by James Allen McKinney from the estate of L. M. Jones and being more specifically described as follows:

BEGINNING at an iron pin in center of the public road on lands now or formerly belonging to F. M. Todd and running thence S 83-30 E, 14.25 along lands of George Yeargin to an iron pin on lands now or formerly of Tom McKinney; thence along Tom McKinney lands S 4-15 W, 20.97 to corner in branch; thence along the said branch N 74-15 W, 1.00 to corner in branch on lands of Mrs. Estelle Knight; thence N 4-15 E, 6.20 to corner; thence N 83-30 W, 13.60 to corner on lands now or formerly of F. M. Todd; thence along the F. M. Todd line N 4-10 E, 15.05 to the beginning corner and containing 22 acres, more or less.
