NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the convenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Greenville Township, being known and designated as Lot No. 21 as shown on a plat of G. J. Douglass Estate recorded in the R. M. C. Office for Greenville County in Plat Book F, at page 126, and being more particularly described according to a recent survey by C. C. Jones as follows:

PEGINNING at an iron pin in the West side of Alamo Street (formerly Hill Street), which pin is 70.65 feet South of the intersection of Alamo Street and Palmetto Street and is the joint front corner of Lots Nos. 21 and 22; and running thence with the joint line of said lots, N.
